CAPIC's center-based educational programming promotes cognitive, social-emotional, physical and language development. Access to health, nutrition, special education and mental health services is available to all. To meet the individual needs of families, the program's schedules vary from 4-hour to 10-hour days, and from a traditional 9-month school year to a year-round schedule.

Family Engagement is the cornerstone of CAPIC Head Start. As the first and most important educators of their children, all parents and families are encouraged and welcomed to participate to the greatest extent possible. Base on families' interests and needs, an array of social and educational activities are planned. 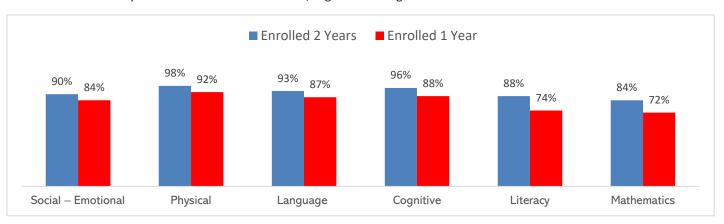
Preparing Children for Kindergarten

CAPIC is committed to providing each child with the highest quality classroom and educational experience. All Teachers have a higher ed degree and participate in on-going professional development and training. The program has implemented two key curricula to prepare children and promote developmental outcomes; OWL (Opening the World to Learning), a literacy-based Curricula and Building Blocks a math-based curriculum. The Pyramid Model is used to support the social-emotional well-being of children.

School Readiness Goals and Outcomes 2023-2024

The program, with input from parents and staff, has established a set of program-wide readiness goals. Each child's development is assessed using the Teaching Strategies Gold[©] assessment tool. Individual outcomes are shared with parents and used to develop individual learning goals. Aggregate data is analyzed to identify trends, opportunities for program improvements and successes to celebrate.

In 2023-2024, the percent of children meeting widely-held expectations in each of the developmental domains was greater for children with two years of enrollment with CAPIC, regardless of age.

Federal Monitoring

CAPIC completed the FA2 Federal Review and was found **100%** in compliance with all Head Start Standards.

The program also participated in the virtual CLASS Observation Review which was a new process for all involved. The Program excelled in Instructional Support and passed the quality threshold for Emotional Support. Classroom Organization came out slightly below the quality threshold.
